



2010 Application Form ORCKA Canoe Tripping Instructor 2 Course

The ORCKA Canoe Tripping Instructor 2 Course aims to provide candidates with instructor-level competence in the instruction and administration of Canoe Tripping courses and programs. The course emphasises the development of appropriate teaching progressions and strategies as well as reinforcing canoe tripping leadership and organisational skills.

Mandate of Canoe Tripping Instructor 2

Upon successful completion of the Canoe Tripping Instructor 2 course, the Instructor may:

- Administer and instruct Safe Canoeing, Basic, Canoe Tripping Level 1, and Canoe Tripping Level 2 courses and programs, in accordance with ORCKA policies
- Instruct at Basic Instructor and Canoe Tripping Instructor 2 courses, by invitation of the director
- Direct a Basic Instructor course, subsequent to instructing at a previous Basic Instructor course and fulfilling other criteria
- Direct a Canoe Tripping Instructor 2 course, subsequent to instructing at a previous Canoe Tripping Instructor 2 course, and being appointed by the ORCKA Board of Directors

The certification and mandate are transferable to other provinces and territories in Canada.

Pre-requisites

1. At least 18 years of age.
2. Current ORCKA member.
3. ORCKA Canadian Style Paddling Level 1 certification.
4. ORCKA Moving Water or River Running Level 1 certification.
5. ORCKA Canoe Tripping Level 3, equivalent certification or comparable skills and experience (with the permission of the Course Director).
6. Minimum of 5 years of canoe tripping activities:
 - a. Log of canoe tripping leadership or shared leadership for a minimum of 50 nights and 1000 kilometres.
 - b. Log of canoe tripping experience to include one or two canoe trips in isolated wilderness areas totalling at least 20 days and covering at least 400 kilometres.
7. It is strongly recommended that all Canoe Tripping Instructors have, in addition to their canoeing qualifications some qualifications in Swimming, First Aid and CPR
8. Prerequisites of all prospective candidates will be authorized by the Instructor Courses Chair, Marty Tannahill, mtannahill@orcka.ca or (705) 533-3576. Please submit for authorization to be completed at least two weeks prior to the course.
